

# Adventurers Charter

Be it known that on this day 16 Septev, 1005, the Adventurers group named below is hereby established as a fully recognized Adventurers group in accordance with Sembian Ordinance LGCO 207.1 As such it is entitled to various privileges as set forth in Sembian Ordinance LGCO 207.1.

## H.A.L.L.O.W.ed Knights

### Mission Statement of the H.A.L.L.O.W.ed Knights

“Dedicating our livelihood to the protection of the innocent, while seeking the eradication of taint, evil undead, and unjust slavery.”

### Privileges proffered under LGCO 207.1A.

- A. 10% reduction in tariffs and taxes associated with salvage of forgotten, lost, or otherwise unclaimed goods.
- B. 10% reduction in docking and licensing fees, as regards private merchant, or pleasure vessels.
- C. 10% discount on all training costs associated with the improvement of adventuring skills.
- D. 10% discount on costs associated with funds transfers, conversions, and security deposits.
- E. 10% reduction in Guild and Union fees if such membership can be shown to be essential to adventuring.
- F. The right to establish a corporate bank account in the organizations name at any Sembian bank.
- G. Representation at local Chartered Groups Council meetings held on the first workday of every month.  
Representation may be direct or surrogated through filed proxy in writing.
- H. Recognition as official representatives of the local Sembian Merchants Council when so empowered.□

### In order to maintain all rights and privileges associated with this charter, the above name organization must comply with the following stipulations/conditions.

- A. A fee of 100 gold pieces must be paid each year to the office of the Registrar at the city of Whillip town hall. This fee must be paid at founding of the organization, and at each anniversary thereafter. If the fee is not paid on time, a 10gp fine will be levied for each week of tardiness. If an entire year passes without payment of fees owed, the contract/charter is cancelled/revoked, and all outstanding fees may be garnished from any funds residing in Sembian banks. If no funds are available, the city may petition a local magistrate for justice.
- B. A complete record of all fees, compensation, goods, booty and other gains obtained through adventuring must be presented to the office of Customs once per year, on the anniversary of the groups chartering.
- C. The organization/group founded under this charter, must present the office of Registrar at the city of Whillip town hall with a copy of all constitutions, charters, and by-laws drafted in order to govern the above named organization/group.
- D. Any time the membership, constitution, or by-laws are changed, a copy of those changes must be forwarded to the office of the Registrar in the city of Whillip (located in the town hall).
